

Outdoor Fire Ring

LIMITED ONE-YEAR WARRANTY

The outdoor Fire Ring by Fire Ring King ("Product") is thoroughly inspected before leaving the factory. It is warranted to be free of defects in workmanship and materials under normal use for one (1) year from date of original purchase. Should any trouble develop during the one year period, you must call the factory, which will at that time determine if you should send back the items for inspection (do not return any merchandise without a R.G.A. Number). If inspection reveals a factory defect, then at our option we will repair or replace at no charge, and Fire Ring King will pay for freight charges. This warranty is subject to the conditions, exclusions and limitations described below.

This warranty applies only to the original owner of the Product and is non-transferable. Fire Ring King's obligation under this warranty does not extend to damages resulting from (1) assembly, operation or maintenance of the Product not in accordance with the Warnings, Installation/Assembly instructions, and Operating instructions; (2) Installation or use which does not comply with state or local building codes and ordinances; (3) shipping, improper handling, improper operation, abuse, misuse, accident or unauthorized repairs; (4) use of fuels other than dry, seasoned hardwood as specified in the Operating Instructions and Warnings; (5) installation or use of components not supplied with the Product or any other components not expressly authorized and approved in writing by Fire Ring King. Any of the circumstances described in the previous sentence voids this warranty. This warranty is void if the Product or any component has been removed, repaired, or replaced before Fire Ring King has been afforded a reasonable opportunity to inspect the Product.

This warranty is limited to the replacement or repair of defective components or workmanship, and Fire Ring King may fully discharge its obligation under this warranty by repairing or replacing, at its discretion, the defective components. Fire Ring King will provide replacement parts at no charge and will pay reasonable and necessary labor and freight cost related to replacing or repairing defective components under this warranty. The maximum amount recoverable under this warranty is limited to the purchase price of the Product and, if Fire Ring King is unable to provide replacement or repair in an expedient and cost-effective manner, Fire Ring King may discharge all obligations under this warranty by refunding the purchase price of the Product.

EXCEPT TO THE EXTENT PROVIDED BY LAW, FIRE RING KING MAKES NO EXPRESS WARRANTIES OTHER THAN THE WARRANTY EXPRESSED HERIN.

THE DURATION OF ANY IMPLIED WARRANTY IS LIMITED TO THE DURATION OF THE WARRANTY SPECIFIED ABOVE.

IN NO EVENT SHALL FIRE RING KING BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES CAUSED BY DEFECTS IN THE PRODUCT OR BY USE OF THE PRODUCT.

FIRE RING KING DISCLAIMS ANY AND ALL OTHER EXPRESS AND IMPLIED WARRANTIES, OF ANY KIND WHATSOEVER, TO THE FULLEST EXTENT PERMITTED BY LAW.
